### We offer the Voters and the General Public the following:

A massive clean out is required!

#### 1. Eradicate Corruption

Radical new policies and laws to expose, prosecute and end corruption in the state sector, in state bodies, in the legal system, the courts, the police, Tusla and throughout the public sector and in the private sector through radical new policies, structures and laws. The setting up of new Structures of Accountability and the Enforcement of full Accountability and Transparency.

#### 2. Lower house prices and rents through the following:

- (a) A massive investment in private affordable housing and social housing including short term, and interim and long term housing solutions. And a massive increase in serviced land to cope with many types of housing solutions.
- **(b)** Extensive use of modular homes, pods, mobile homes, and alternative housing solutions with serviced land for short term and emergency solutions.
- **(c)** Grants and tax incentives to convert 100,000 empty, boarded up, and derelict properties into residential units in towns and cities. Vacant Property tax of 25%. This would bring a massive number of properties onto the Irish market reducing rents and property prices.
- **(d) Mass Deportations** of illegal migrants and the closure of IPAS centres and an end to open borders and mass migration. Mass deportations needs to start at 60,000 people per year. This includes those who got Irish citizenship under false pretences. This will reduce the massive artificial demand for housing which has led to very high house prices and rents which Irish people cannot afford.
- **(e)** Radical changes to credit and money creation by banks as advised by Dr. Steve Keen and Dr. Richard Werner to stop price speculation for homes and stabilise property prices and rents. National debt restructuring, including write downs and write offs, and monetary reforms to create massive new investment in private housing and social housing.
- **(f)** Tax incentives and special grants and compulsory purchases to release the land hoarded in land banks onto the market for affordable private housing, social housing and emergency housing.
- **(g)** Strategic compulsory purchases of land and property to provide affordable housing solutions and land servicing solutions for Irish people, prioritising young Irish couples and families and the homeless Irish.
- (h) Tax incentives to stop overcharging for sites of land
- (i) while there is a housing crisis and homeless crisis in Ireland, native Irish citizens would be prioritised in housing sales, rents and housing solutions. Relax or eliminate planning requirements and red tape for all native Irish people in rural areas who want to build their own homes.

In addition to increasing housing supply and land supply and reducing costs, house prices will be capped at 5 - 7 times average annual earnings so as to prevent more theft and robbery of the Irish people and nation. And monthly rents capped at 90% of average weekly earnings. Big reductions in mortgage payments through radical new policies, structures and laws.

#### 3. Vulture Funds

Our people have taken court cases against the Vulture Funds and defeated the Vulture Funds in court. We have exposed the frauds of the Vulture Funds. We have helped save the homes of Irish families. We will implement new laws and policies to end the frauds committed by Vulture Funds and expose, prosecute their frauds and crimes in the courts.

#### 4. Deportations

Mass deportations of illegal migrants and the closure of IPAS centres. Deportations starting at 60,000 people per year. Remove Ireland from the EU Migration Pact and certain provisions of ECHR and let Ireland have its own independent migration policies and full control over it's borders. This will save over 2 billion euros per year. An end to Open Borders

and Mass Migration into Ireland so as to protect Irish wages and worker's rights and take the population pressures off housing

prices, rent prices, housing availability, hospital places, school places, hotel rooms for tourists, etc.. This would also make towns and cities safer and more business friendly and tourist friendly. We refer to the web site at <a href="https://migrant-crime.org/">https://migrant-crime.org/</a>

#### 5. Remove all government and state funding for over 95% of NGO's

The NGO's are costing Ireland over 7 billion per year and they do nothing for the Irish people and nation and nothing for the Irish economy. They drain tax revenues and reduce the money available for schools, hospitals, business investment, and infrastructure and enrich far left extremists who are destroying Ireland and its economy, society and culture. Force the NGO's to become self financing, and do fund raising in south Dublin, Bray and Greystones and other 'woke' areas.

#### 6. Taxes

Large reductions in taxes and a low tax environment. New Policies to bring about a massive reduction in the national debt and accompanying large reductions in taxes and the creation of a new low tax environment and a new low debt environment which promotes work, investment, consumer spending, Democratic Capitalism, Economic Democracy, and a fairer distribution of economic resources fuelling strong and stable employment creation and economic growth. Increase both foreign direct investment and native domestic investment throughout Ireland and regenerate the cities, towns and villages of Ireland and rural Ireland. This will benefit the working classes, the middle class and the professional classes and business class and help end social and economic exclusion.

Large reductions in taxes will be achieved via a vast restructuring of the entire economy to end Debt Slavery. The removal of Debt Slavery will give the Irish government the ability to reduce all taxes and eliminate some taxes and massively invest in the Irish economy and Irish infrastructure including schools, hospitals, childcare, policing, etc. and in Irish society. Massive new investment in hospitals, fitness and diet programmes for everybody, alternative health programmes, schools, Universities, the vast expansion of private housing and social housing, in gardai and garda stations and more effective crime prevention programmes, improved wages and conditions for military personnel, light rail in cities and towns, completion of the western rail corridor etc.

7. Remove Ireland from the Euro currency which has reduced Ireland down to being a beggar from the ECB and create a strong and stable national currency based on hard assets and infrastructural assets which grows in line with economic output and productive investment in hard assets not speculation in asset prices, and financial bubbles and crashes. Restore fiscal and monetary power to the Irish governent. Renegotiate all treaties with the EU so as to decrease European Union control over Ireland and it's laws. Restore Irish national sovereignty. Restore the European Common Market with Britain and Eastern European countries included.

# 8. End and Reverse new Compulsory Purchase laws where the Irish state can seize your home, land and property and give it to others

These new compulsory purchase laws are a direct attack on the property rights and Irish Constitutional rights sof ordinary Irish people and families all around Ireland. These laws have emerged from the WEF and its leader Kluas Schwab who declared that "you will own nothing and be happy." The WEF membership includes the EU President and many EU Commissioners and top rankling MEP's in the EU Parliament. We are being ruled by thieves and criminals.

#### 9. Inflation and the Price of Goods

New Policies to bring a large reduction in inflation and in the cost of living for famillies and individuals and in the cost of energy, goods and services through radical new policies, structures and laws. A 30 - 40% reduction in the cost of living in terms of lower food prices, lower energy prices, lower goods and service prices, lower taxes, lower rents, and lower mortgage payments.

- **11.** Massive new investment in rural Ireland, in farming, in agri businesses, in farmer share ownership of agri businesses, in market expansion nationally and internationally, in new tech businesses and remote working, in affordable fuel for farming, in towns and villages and community regeneration. An End to carbon taxes and crazy net zero policies which bankrupt economies
- **15.** Re-unite Ireland and create a 32 county Irish Republic or Eire and a 32 county Dail Eireann through Referendums as stated in the Good Friday Agreement of 1998. For over 25 years the big political parties have refused to do this.
- **16.** Protect Irish neutrality which is being attacked and undermined by the big political parties in Ireland. Work with governments and organisations in other nations to promote Peace and Justice and Healing around the world
